- Assessment of the accounting principles used and significant estimates made by management;
- Evaluation of the overall financial statement presentation.

The audit will also include an examination, on a test basis, of evidence supporting compliance in all material respects with the relevant laws and regulations which came to our attention and are applicable to financial matters.

#### 1 DETAILED FINDINGS AND RECOMMENDATIONS

## 1.1 Compliance Issues

### 1.1.1 Uncompleted Project Deliverables

#### Observation

- 1.1.1.1 Section II (1) of the LFSP Grant Agreement states that "The recipient shall cause the Project Implementing Entity to monitor and evaluate the progress of the Project and prepared project reports in accordance with the provisions of section 2.06 of the standard conditions and on the basis of indicators acceptable to the World Bank. Each Project Report shall cover the period of one (1) calendar semester, and shall be furnished to the World Bank not later than forty-five (45) days after the end of the period covered by such report".
- 1.1.1.2 It was observed during the conduct of the audit that key project activities, target dates and deliverables agreed with the World Bank were not achieved by the Project Implementing Entities (PIEs). **Refer to Appendix 1 for details.**

#### **Risk**

- 1.1.1.3 Project objectives may not be achieved in the absence of effective project implementation and coordination.
- 1.1.1.4 The absence of effective monitoring and evaluation of project deliverables may deny the achievement of value for money during the execution of the project.

#### Recommendation

- 1.1.1.5 Management should ensure that the project deliverables are implemented in line with the project work plan.
- 1.1.1.6 Management should ensure that proper coordination, monitoring and evaluation of the PIEs are implemented periodically during the execution of the project.

#### **Auditor General's Position**

- 1.1.1.7 We acknowledge Management's assertions. We will make follow-up on the implementation during subsequent audits.
- 1.1.1.8 However, we maintain our finding and recommendation.

#### 1.1.2 Lack of Forest Trees Maintenance

#### Observation

- 1.1.2.1 Section II (1) of the LFSP Grant Agreement states that "The recipient shall cause the Project Implementing Entity to monitor and evaluate the progress of the Project and prepared project reports in accordance with the provisions of section 2.06 of the standard conditions and on the basis of indicators acceptable to the World Bank. Each Project Report shall cover the period of one (1) calendar semester, and shall be furnished to the World Bank not later than forty-five (45) days after the end of the period covered by such report"
- 1.1.2.2 It was observed during the conduct of the audit that maintenance activities and the construction of Fire lines to protect the growth of afforestation and agroforestry plants from bush fires have not been implemented by the LFSP Management. **See Photo below for details.**

1.1.2.3 We noted, from a review of project document, that over 100 acres of afforestation trees and agroforestry plants require maintenance and fire lines protection.

#### Risk

- 1.1.2.4 Forest trees could be subjected to uncontrollable bush fires and/or other damages in the absence of fire line protection and maintenance.
- 1.1.2.5 The absence of effective monitoring and evaluation of project deliverable may deny the achievement of value for money during the execution of the project.

#### Recommendation

- 1.1.2.6 The LFSP Management should ensure the timely maintenance and construction of fire lines to protect afforestation trees and agroforestry plants in line with the project work plan.
- 1.1.2.7 Management should ensure that proper coordination, monitoring and evaluation of the PIEs are implemented periodically during the execution of the project.

#### **Management's Response**

1.1.2.8 We note that the LFSP Management should ensure the timely maintenance and construction of fire lines to protect afforestation trees and agroforestry plants in line with the project work plan. It is important to note that these trees have grown and maintenance is done strategically in different parts of the plantation on a technically need to do basis. The importance of the plantation is regreen the area and ensure a balance in ecology and biodiversity. Completely clearing the under brushes of the grown-up trees could expose the place to erosion which could have a negative impact on the area and reverse some of the gains the project has made.
