### **Opinion**

We have audited the financial statements of Rural Community Finance Project (RCFP): IFAD Loan: 2000000631, Grant 2000001474 for the year January 1, 2022 to December 31, 2022, which comprise the statement of Receipts and Payments, statement of Comparison of Budget and Actual Amounts and summary of significant accounting policies and other explanatory information.

In our opinion, the accompanying financial statements present fairly, in all material respects, the statement of Receipts and Payments as at December 31, 2022, the statement of Comparison of Budget and Actual Amounts and summary of significant accounting policies and other explanatory information for the year then ended in accordance with International Public Sector Accounting Standards (IPSAS 2017) Cash Basis of Accounting.

### **Basis for Opinion**

We conducted our audit in accordance with International Standards of Supreme Audit Institutions (ISSAIs). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are independent of the International Fund for Agriculture Development (IFAD) Project Implementing Unit (PIU) of the Ministry of Agriculture (MoA) in accordance with the ethical requirements that are relevant to our audit of the financial statements in Liberia, and we have fulfilled our other ethical responsibilities in accordance with these requirements.

We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our opinion.

### **Responsibilities of Management and Those Charged with Governance for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with International Public Sector Accounting Standards (IPSAS 2017) Cash Basis of





Accounting and for such internal control as management determines is necessary to enable the preparation of financial statements that are free from material misstatement, whether due to fraud or error.

### **Auditor's Responsibilities**

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance, but is not a guarantee that an audit conducted in accordance with ISSAIs will always detect a material misstatement when it exists. Misstatements can arise from fraud or error and are considered material if, individually or in the aggregate, they could reasonably be expected to influence the economic decisions of users taken on the basis of these financial statements.

## **BACKGROUND INFORMATION ON THE PROJECT**

The total cost of the RCFP is USD 10.862 million financed from an IFAD highly concessional loan of USD 5.504million, IFAD Grant SD 0.490 million, contributions (in-Kind) from Domestic Institutions (USD 1,231 million), Beneficiaries (USD 3.240million), the GoL (USD 0.397 million) The RCFP financing agreement was signed on February 22, 2016; the financing agreement was ratified by the Government of Liberia and became effective in October 2017. The RCFP is a five-year project geared at enhancing access to sustainable and affordable rural financial services in Liberia.

The project consists of Three (3) components, namely: (a) Rural financial services; (b) Enabling environment for rural finance; and (c) Project management and coordination. The rural financial services component will have two sub-components: RCFI creation and operation, which will support the creation of grassroots rural community finance institutions (RCFIs) along the institutional models already practiced in Liberia; and Technical assistance and supervision, involving the creation of a Technical Assistance and Supervision Unit/Company (TASU/TASC). No sub-components are envisaged for Components 2 and 3.

## **PROJECT OBJECTIVE**

The project objective is to improve access by rural people to formal financial services on a sustainable basis, enabling the development of the rural sector. This objective, will at the end of the project be assessed through three indicators: (i) Outreach of RCFIs: At least 20% of the adult rural population (16 years) in the project districts use financial services of the RCFIs supported by the project (disaggregated by gender/age); (ii) Lending operations of RCFIs: At least 50% of RCFI shareholders have received at least one loan (disaggregated by loan sizes/terms, gender, age, purpose); and (iii) Sustainability of RCFIs: At least 75% of the RCFIs supported achieve at least 100% Operational Self-Sufficiency (OSS) by the end of the project.

**SUMMARY OF PERFORMANCE**

During the year ended December 31, 2022, the project received US\$ US\$ 616,278.22 from IFAD with balance brought forward from prior year of US\$748,751.55 (US\$543,571.88 IFAD Loan and US\$199,888.29), making a total of US\$ US\$1,365,029.77 for implementation of planned activities. The Annual Work Plan and Budget (AWPB) for the project was projected at US\$1,368,294.65 (One Million Three Hundred Sixty-Eight Thousand Two Hundred Ninety-Four United States Dollars 65/100). Actual expenditure incurred for the reporting year is US\$900,852.65 including amongst other things; procurement of equipment, local training, study tours, share contributions to shareholders of RCFIs, National consultancy, staff salary payment and operating activities.

From project inception, a total of US\$3,247,092.16 (Three Million Two Hundred Forty-Seven Thousand Ninety-Two United States Dollars 16/100) has been disbursed from the IFAD Loan (US\$3,047,092.16 and IFAD grant, US\$200,000.00) whereas expenditures incurred from start to date is US\$2,782,915.04.

The project financing agreement required the project management team to prepare the financial statements in accordance with the financial requirement of the International Fund for Agricultural Development Financing Agreement and the International Public Sector Accounting Standards (IPSAS) under the Cash Basis of Accounting. The RCFP execution rate is negative 34% against budgeted. This variance is due to major decisions taken during the IFAD Mission to implement several activities since the project was in its closure stage. However, a six (6) months AWPB was approved and No Objection obtained in order to complete outstanding activities. Category I, Consultancies is below budgeted amount because consultancies during the reporting period were not completed. For Category II, Training (and workshop) is 25% below budgeted most of the training were not conducted. Category IV, Equipment, materials and vehicles is 14% less budgeted because the purchased of assets and other inputs placed on hold in previous years AWPB were delayed. This affected the under performance during the period under audit. Category V, Grant and subsidies is 27% against budgeted amount because shares to be matched in previous years were still being validated and payment made during this reporting period. This also is reflected in the implementation of the grant budget. The variance in salaries and allowances budget reflect the cost of NASSCROP and Withholding taxes for the previous quarter that was paid in the reporting period. Operating Costs is 41% below budgeted amount and these project vehicles are fast deteriorating and rough terrain in which they operate. Also, the rise in inflation is reflected in the overspending in some of the operating cost.

**1. Financial Reporting Under the International Public Sector Accounting Standards (IPSAS)**

Fixed assets are expensed on acquisition and a comprehensive fixed assets register is maintained.

**d. Income**

Funding from IFAD loan is recognised in the programme's income statement when disbursement is made to the Project accounts or to vendor's accounts upon project request.
